MONTHLY RATE SCHEDULE

RESIDENTIAL SERVICE

First 0 - 10,000 gallons (or fraction) \$24.50
 Over 10,000 gallons See "Water Usage Over Minimum"

MULTI-FAMILY SERVICE

1 - 4 Units 0 - 10,000 gallons each/unit \$24.50 each/unit
 Over 10,000 gallons See "Water Usage Over Minimum"
 Over 4 Units 0 - 5,000 gallons each/unit \$15.00 each/unit
 Over 5,000 gallons See "Water Usage Over Minimum"

COMMERCIAL SERVICE

<u>Size of Service</u>	<u>Minimum</u>	<u>Monthly Service Charge</u>
3/4"	0 - 10,000 gal.	24.50
1"	0 - 10,000 gal.	27.50
2"	0 - 10,000 gal.	35.00
3"	0 - 10,000 gal.	40.00
4"	0 - 10,000 gal.	50.00

Water usage over 10,000 gallons per month shall pay rates as set forth in "Water Usage Over Minimum".

STANDBY FIRE PROTECTION

<u>Size of Service</u>	<u>Monthly Service Charge</u>
2"	25.00
3"	30.00
4"	35.00
6"	40.00

WATER USAGE OVER MINIMUM

To the above minimum monthly charges for usage in excess of 10,000 gallons per month shall be added charges according to the following rates:

Next 10,000 gallons, rate per 1,000 gallons	\$.75
Next 20,000 gallons, rate per 1,000 gallons	1.00
All over 40,000 gallons, rate per 1,000 gallons	2.00

SERVICE CONNECTION CHARGES

The charge for installing a new service which includes excavation, backfill, tapping the main, laying the pipes, installing the meter, yoke and meter box, and replacement of surfacing materials shall be as follows:


<u>Meter Size</u>	<u>Charge</u>
As Determined by Water Department	Actual Cost of Installation plus 15%

NEW USER FACILITY FEE (NUFF)

- a. At the time that application is made for a new service, the applicant shall deposit with the City of Dover a New User Facility Fee in the amount of \$3,500.00 per Equivalent User (ER) as determined by the Water Department. An Equivalent User is equal to the amount of water used by a typical single-family residence. A typical ER is considered to be equal to 10,000 gallons of water per month.
- b. For new construction only, prior to first occupancy, NUFF may be paid in equal monthly installments not to exceed three months provided the applicant executes a written contract with the City.

These water rates shall be reviewed annually by the Water Department and adjustments shall be made by action of the City Council.

The rates herein provided to be paid and collected, shall be effective for all collection periods beginning on or after the date of this resolution.
